If no suitable meeting place exists inside the district, the board may designate a meeting place outside the district that is located not further than 10 miles from the boundary of the district. On the failure, after a request is made of the board to designate the location of the meeting place within the district or not further than 10 miles from the boundary of the district, five electors may petition the Texas Commission on Environmental Quality ("the TCEQ") to designate a location. If the TCEQ determines that the meeting place used by the district deprives the residents of a reasonable opportunity to attend district meetings, the TCEQ shall designate a meeting place inside or outside the district which is reasonably available to the public and require that the meetings be held at such place.
- 3. Receive public comments.
- 4. Adopt Order Calling Directors Election.
- 5. Adoptar Orden Convocatoria Elección de Directores
- 6. Approve agreements for holding of elections.
- 7. Aprobar acuerdos para la celebración de elecciones.
- 8. Consider, discuss, and take action regarding annexation of land by the District, including approving an order adding land to the District.
- 9. Review, approve, and authorize the filing of district information forms and maps.
- 10. Consider and take action regarding payment of bills and invoices.
- 11. Consider and take action to approve payment of director per diems.
- 12. Consider and take action regarding future meeting dates, and such other matters as may come before the Board.
- 13. Adjournment.

The District may meet in executive session on any item listed above as authorized by the Open Meetings Act, Tex. Gov't. Code Ann. Chapter 551 or by Texas Government Code Section 418.183.
